MEMORANDUM NO. 2026-02-0423 TITLED, "ISSUANCE OF CERTIFICATE OF
ACCEPTANCE (CA) FOR DELIVERED TEXTBOOKS (TXs), TEACHER'S MANUALS
(TMs), AND LEARNING TOOLS AND EQUIPMENT (LTE-SME/TVL)**

1. This Memorandum is issued to disseminate the DepEd-Bureau of Learning Resources (BLR) Memorandum No. 2026-02-0423.
2. Pursuant to the said memorandum, recipient offices or delivery sites shall verify the completeness and condition of the delivered items and immediately issue the Certificate of Acceptance (CA) to the supplier upon confirmation that the delivered items are complete and compliant with the required specifications.
3. The issued Certificate of Acceptance (CA) shall be accompanied by photocopies of the duly accomplished and signed Inspection and Acceptance Report (IAR) and Delivery Receipt (DR) to support proper documentation and validation of the delivered items.
4. Furthermore, as stipulated in BLR Memorandum No. 2026-06-1527, titled **"Addendum to the Memorandum on the Issuance of Certificate of Acceptance (CA) for Delivered Textbooks (TXs), Teacher's Manuals (TMs), and Learning Tools and Equipment (LTes),"** the requirement to issue a CA shall likewise apply to the following procurement projects:
 - Supply and Delivery of Textbook and Teacher's Manual Titles, including the Provision of Electronic Textbooks (TXs) and Teacher's Manuals (TMs) for Grades 2, 5, and 8;
 - Provision of Textbooks, Teacher's Manuals, and Electronic Textbooks (TXs) and Teacher's Manuals (TMs) for Senior High School (SHS) Core Subjects; and
 - Other Learning Resource Procurement Projects implemented by the DepEd-Bureau of Learning Resources (BLR).
