 - g. Conduct Post-qualification;
 - h. Prepare Post-qua reports and Resolution of Request for Reconsideration.
 - i. Assist the BAC in the evaluation and preparation of recommendations on requests for reconsideration and other procurement-related technical matters.

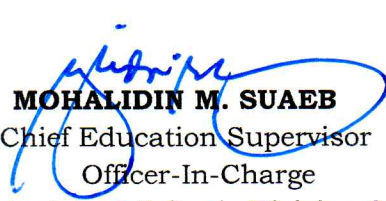
